Please note: There will be opportunities to volunteer at the Eden Project outside of timetabled sessions.

Timetables/Handbooks and other essential information will be given to you during Induction week

Your first day will be an induction day and provides an opportunity to meet staff and other students, find your way around the site, finalise enrolment, and generally settle in to what we hope will be a challenging and enjoyable year.

Please note that Master's degrees run for a calendar year and your last date as a student is the last working day in August of the year that you complete (August 31st 2025 for full-time; August 31st 2026 for part-time).

Additional Course requirements:

Steel toe-capped safety boots and appropriate outdoor weather clothing for field trips and practical work outside. You may need to consider the use of a laptop/access to suitable IT at home.

Please can you send an electronic passport style photograph of yourself to kate.foster@cornwall.ac.uk which will be used to produce your ID badge. In submitting your photograph, you are providing consent to The Cornwall College Group to share it with the Eden Project to validate your presence on their site in association with the College. There may be some additional costs whilst on your programme for educational visits and materials i.e. clothing, memory sticks. Trips are rarely mandatory but do enrich your learning.

Online Enrolment

We will be in touch via email, over the summer, asking you to complete your **online enrolment** – please remember to check your spam, just in case it gets diverted! Please Note - the release of your Student Finance loan payments are dependent upon completion of the Enrolment process, so the sooner you enrol, the quicker we can instruct the Student Loan Company to release your loan payments (if applicable).

Please Note: Our Online Enrolment platform does not support Safari, so we recommend you use Microsoft Edge or Google Chrome to complete your Online Enrolment. If you have any difficulties, please check that you enter your surname correctly and date of birth as: DD/MM/YYYY - ensure this is your birth year and not the current year! Finance

If you haven't already done so, we would like to remind you to apply to Student Finance for help with your tuition fees (if applicable) and any loans/grants that you may be entitled to at: www.gov.uk/studentfinance.

There may be some additional costs whilst on your programme for educational visits and materials i.e. clothing, memory sticks. Trips are rarely mandatory but do enrich your learning.

Council Tax Exemption certificates will be available from mid-September.

Payment of Fees, If Self-Funding

If you are applying for Student Finance to pay your fees, the fee amount will be automatically transferred to us directly from them. However, if you are self-funding your studies, you will need to pay for your tuition fees direct. The 1st payment, 25% of your annual tuition fee, is due on or before the start of the academic year. After the initial payment, you will need to make a payment schedule with our Finance Team to pay the remaining balance, in full, by the end of the academic year. It is important to keep up with your payment schedule, as failure to do so will result in your network access being suspended and you may be asked to leave your programme of study.

As you complete the end of each year of study, all outstanding fees must be paid otherwise you will not receive your end of year transcript/s or receive authorisation to continue studies (if applicable).

If you have previously studied with the Cornwall College Group at any of our sites, and have outstanding debts you must arrange to pay these, in full, by 1st September 2025. Your enrolment will not be processed, nor will you be allowed to attend until your account is cleared.

Transferring Into Cornwall College

If you enrol on a HE programme at another institution in the 2025/26 academic year, then transfer to the Cornwall College Group before 25th October 2025, you will be a 'Late Transfer'. The original institution may retain 25% of the tuition fees if funded by the Student Loan Company. If the Cornwall College Group is unable to recoup this 25%, you will only be liable to pay the Cornwall College Group the remaining 75%.

If you are claiming for Accredited Prior Learning, your tuition fee may be adjusted to reflect the number of modules you will actually be studying.

Late Starters

Learners classified as late starters are those students who start after the official HE term start date and **have not** transferred from another institution will be charged the full annual tuition fee (unless eligible for Accreditation of Prior/Experiential Learning).

Withdrawing/Suspending Studies during the Academic Year 2025/26

If, during the first few weeks of study you decide your chosen programme is not for you, please let us know as early as you can. If you withdraw from your studies and begin a new programme on/after 1st September 2025 you will be deemed a new student and will adopt the new tuition fee for the academic year your studies commence.

The Cornwall College Group will operate the following fee policy for undergraduate or postgraduate taught students who withdraw or suspend their studies:

Withdrawal / Suspension	Fees Payable
New learners who enrol onto the first year of their programme, who withdraw or suspend studies between 15th September 2025 and 30th September 2025 .	No Charge
Learners who are resuming studies with extenuating circumstances, who withdraw or suspend studies between 15th September 2025 and 30th September 2025	No Charge
New Learners who are enrolling onto the first year of their programme, who withdraw or suspend studies between 1st October 2025 and 18th December 2025	25% of annual tuition fee is payable
All Learners continuing, repeating or resuming studies, who withdraw or suspend studies between 15th September 2025 and 18th December 2025	25% of annual tuition fee is payable
All Learners who withdraw/suspend between 6th January 2026 and 2nd April 2026	50% of annual tuition fee is payable
All Learners who withdraw/suspend between 20th April 2026 to the end of the 2025/26 academic year	100% of annual tuition fee is payable

Learners who suspend studies due to valid and extenuating circumstances will be liable for the suspension fees above but the fee they pay when they resume studies will take the charges into consideration.

Finally, attendance has been shown to link very strongly with the success of students. Your attendance will be monitored throughout the programme and will be expected to be over 85%. Should you fail to meet a 90% benchmark during the first three weeks you will be asked to discuss your attendance with your personal tutor. If this meeting is unsatisfactory you may be asked to leave the College.
