#### Online Enrolment

We will be in touch via email, over the summer, asking you to complete your **online enrolment** – please remember to check your spam, just in case it gets diverted! Please Note - the release of your Student Finance loan payments are dependent upon completion of the Enrolment process, so the sooner you enrol, the quicker we can instruct the Student Loan Company to release your loan payments (if applicable).

**Please Note:** Our Online Enrolment platform does not support Safari, so we recommend you use Microsoft Edge or Google Chrome to complete your Online Enrolment. If you have any difficulties, please check that you enter your surname correctly and date of birth as: DD/MM/YYYY - ensure this is your birth year and not the current year! If you have any other problems please email enquiries@cornwall.ac.uk.

#### **Finance**

If you haven't already done so, we would like to remind you to apply to Student Finance for help with your tuition fees (if applicable) and any loans/grants that you may be entitled to at: <a href="www.gov.uk/studentfinance">www.gov.uk/studentfinance</a>. There may be some additional costs whilst on your programme for educational visits and materials i.e. clothing, memory sticks. Trips are rarely mandatory but do enrich your learning.

Council Tax Exemption certificates will be available from mid-September.

#### **Payment of Fees, If Self-Funding**

If you are applying for Student Finance to pay your fees, the fee amount will be automatically transferred to us directly from them. However, if you are self-funding your studies, you will need to pay for your tuition fees direct. The 1<sup>st</sup> payment, 25% of your annual tuition fee, is due on or before the start of the academic year. After the initial payment, you will need to make a payment schedule with our Finance Team to pay the remaining balance, in full, by the end of the academic year. It is important to keep up with your payment schedule, as failure to do so will result in your network access being suspended and you may be asked to leave your programme of study.

As you complete the end of each year of study, all outstanding fees must be paid otherwise you will not receive your end of year transcript/s or receive authorisation to continue studies (if applicable).

If you have previously studied with the Cornwall College Group at any of our sites, and have outstanding debts you must arrange to pay these, in full, by I<sup>st</sup> September 2025. Your enrolment will not be processed, nor will you be allowed to attend until your account is cleared.

## **Transferring Into Cornwall College**

If you enrol on a HE programme at another institution in the 2025/26 academic year, then transfer to the Cornwall College Group before 25<sup>th</sup> October 2025, you will be a 'Late Transfer'. The original institution may retain 25% of the tuition fees if funded by the Student Loan Company. If the Cornwall College Group is unable to recoup this 25%, you will only be liable to pay the Cornwall College Group the remaining 75%.

If you are claiming for Accredited Prior Learning, your tuition fee may be adjusted to reflect the number of modules you will actually be studying.

#### Withdrawing/Suspending Studies during the Academic Year 2025/26

If, during the first few weeks of study you decide your chosen programme is not for you, please let us know as early as you can. If you withdraw from your studies and begin a new programme on/after 1<sup>st</sup> September 2025 you will be deemed a new student and will adopt the new tuition fee for the academic year your studies commence.

The Cornwall College Group will operate the following fee policy for undergraduate or postgraduate taught students who withdraw or suspend their studies:

Learners who suspend studies due to valid and extenuating circumstances will be liable for the suspension fees above but the fee they pay when they resume studies will take the charges into consideration.

Finally, attendance has been shown to link very strongly with the success of students. Your attendance will be monitored throughout the programme and will be expected to be over 85%. Should you fail to meet a 90% benchmark during the first three weeks you will be asked to discuss your attendance with your personal tutor. If this meeting is unsatisfactory you may be asked to leave the College.

#### **IMPORTANT INFORMATION RE FEE PAYMENTS IF SELF-FUNDING**

If you are paying your own fees, you will be expected to make an initial payment of 25% of your annual tuition fee on or before the start of the academic year, you will then need to arrange a payment scheme in order to pay the balance in full by the end of the academic year. If we do not receive any payments from you by the end of the first academic term (December) your network access will be suspended and you may be asked to leave your programme of study.

Please go to your campus site administration office where you can make your first payment and arrange to pay the remaining annual tuition fee balance. If this facility is not available on your site or you wish to make a payment before your programme of study commences please call 01209 617775 (Finance Office) or email <a href="mailto:sales.ledger@camborne.ac.uk">sales.ledger@camborne.ac.uk</a>.

As you complete the end of each year of study, all outstanding fees must be paid otherwise you will not receive your end of year transcript/s or receive authorisation to continue studies (if applicable).

If you have previously studied with The Cornwall College Group (all sites) and currently have any outstanding debts you must arrange to pay these in full by Ist September 2024. Your enrolment will not be processed, nor will you be allowed to attend until your account is cleared.

If you enrol and attend a HE programme at another institution in the 2024/25 academic year, and subsequently transfer to The Cornwall College Group within the same academic year (no later than 28th October 2024), you will be deemed as a 'Late Transfer'. If your tuition fees are funded by the Student Loan Company, the original institution may retain 25% of the student loan. If The Cornwall College Group is unable to recoup this 25% from the institution, you will only be liable to pay The Cornwall College Group the remaining 75%.

If you are claiming for Accredited Prior Learning your tuition fee may be adjusted to reflect the number of modules you will actually be studying.

#### **LATE STARTERS**

Learners classified as late starters are those students who start after the official HE term start date and **have not** transferred from another institution will be charged the full annual tuition fee (unless eligible for Accreditation of Prior/Experiencial Learning).

## WITHDRAWING/SUSPENDING STUDIES DURING THE ACADEMIC YEAR COMMENCING SEPTEMBER 2024

If you withdraw from a programme and then begin a new programme on or after 1st September 2024 you will be deemed to be a new student and will adopt the new tuition fee for the academic year in which you commence study.

The Cornwall College Group will operate the following fee policy for undergraduate or postgraduate taught students who withdraw or suspend their studies:

Withdrawal / Suspension	Fees Payable
New learners who are enrolling onto the first year of their programme, who withdraw or suspend studies between 16 <sup>th</sup> September 2024 and 30 <sup>th</sup> September 2024. This also applies to learners who are resuming studies with extenuating circumstances, who withdraw or suspend studies between 16 <sup>th</sup> September 2024 and 30 <sup>th</sup> September 2024	No Charge
New Learners who are enrolling onto the first year of their programme, who withdraw or suspend studies between 1st October 2024 and 19th December 2024	25% of annual tuition fee is payable
All Learners who are continuing study, repeating their studies or resuming studies, who withdraw or suspend studies between 16 <sup>th</sup> September 2024 and 19 <sup>th</sup> December 2024	25% of annual tuition fee is payable
All Learners who withdraw or suspend studies between 7th January 2025 and 4th April 2025	50% of annual tuition fee is payable
All Learners who withdraw or suspend studies between 22 <sup>nd</sup> April 2025 to end of 2024/25 academic year	100% of annual tuition fee is payable

Learners who suspend studies due to valid extenuating circumstances will be liable for the suspension fees above but the fee they pay when they resume studies will take into account these charges.

Finally, attendance has been shown to link very strongly with the success of students. Your attendance will be monitored throughout the programme and will be expected to be over 85%. Should you fail to meet a 90% benchmark during the first three weeks you will be asked to discuss with your personal tutor. If this meeting is unsatisfactory you may be asked to leave the College.
